Chamber Membership: A logical decision for any business in Polokwane

The benefits of joining the Polokwane Chamber of Business are numerous.

- The Chamber represents its members on a number of formal government bodies, at a local as well as provincial level. Through its affiliation to SACOB (the South African Chamber of Business), members enjoy representation at a national level as well. The Chamber therefore ensures that the voice of business is heard at all levels.
- During the past few years the Polokwane Chamber of Business has enjoyed the increased respect of local government and we are consulted by local authorities on a wide range of issues, especially regarding economic development and safety.
- The Polokwane Chamber of Business provides important networking opportunities for its members. Monthly business card networking evenings are held, as well as a number of business lunches throughout the year where members are addressed on relevant subjects. Our Annual Golf day has become a showcase of local business.
- The Chamber recognises service excellence by handing over certificates to nominated businesses on a monthly basis. The highlight on its social calendar is the annual banquet where the Business Personality of the Year is announced, while recognition is also given during the occasion to individuals or organisations that have excelled in a number of other categories.

- The Chamber endeavours to keep its members up to date regarding changes in legislation and policy that affect our members and, through SACCI's Parliamentary Office in Cape Town, is able to exert influence over national legislation as well.

The membership fees are determined as follows, according to the number of employees the member has:

1 - 5 employees	:	R550.00 p.a.
6 - 15 employees	:	R900.00 p.a.
16 -24 employees	:	R1450.00 p.a.
25 + employees	:	R1950.00 p.a.

Each member also pays a SACCI affiliation fee of R55.00 p.a. and new members are charged a once-off administration fee of R75.00. (All aforementioned amounts include VAT).
